SEALED BIDS will be received by the Caddo Parish School Board, 1961 Midway Street, Shreveport, Louisiana, in the Construction Office Building front door or electronically at Bidexpress.com, until April 12, 2022 at 3:00 P.M. for Keithville Roofing, Phase I, Project No.: 2023-242

Complete Bidding Documents may be obtained from Newman Marchive Incorporated, 2800 Youree Drive, Suite 310 Shreveport, Louisiana 71104 upon receipt of \$ 50.00 for each set of documents. If Bidder wants the documents to be sent to them, there will be a shipping and handling fee of \$50.00 charged to the bidder. Deposit is fully refundable to all bonafide prime bidders who submit a bid upon return of the documents, in good condition no later than ten (10) days after receipt of bids. Bidding documents will be available in the office of the Designer on or about March 17, 2022. NOTE: LOUISIANA LICENSED CONTRACTOR REQUIRED FOR THIS PROJECT WITH A MAJOR CLASSIFICATION AS BUILDING CONSTRUCTION OR SPECIALTY: ROOF AND SHEET METAL, SIDING.

BID SECURITY equal to five percent (5%) of the Total Bid shall be in the form of a bid bond, certified check or cashier's check as prescribed by LA RS 38:2218.A must be attached to and made a part of the bid. If a bid bond is provided it shall be on the provided form and only on the provided form. Bid bonds must be written by a qualified company licensed to do business in Louisiana.

The successful bidder will be required to furnish a Performance Bond written by a company licensed to do business in Louisiana in an amount equal to one hundred percent (100%) of the contract amount.

For this project, Liquidated Damages will apply in the amount of \$ 400.00 per day for each consecutive calendar day which the work is not completed, beginning with the first day beyond the established completion date of 60 days.

No bid may be withdrawn for a period of forty-five (45) days after actual date of the opening thereof.

The Board reserves the right to reject any and all bids.

The Caddo Parish School Board desires that Bidders make a good faith effort to utilize 25% small and economically disadvantaged businesses.

A MANDATORY PRE-BID CONFERENCE will be held on April 1, 2022, at 9:00 A.M. Contractors must report to Keithville Elementary/Middle School, 12201 Mansfield Road, Shreveport, Louisiana. Sign-in will be at the meeting location between 8:30 A.M. and 9:00 A.M. Meeting will be closed at 9:00 A.M. Persons arriving after the meeting starts will not be allowed to submit a prime bid for the project. Attendance at the pre-bid conference by an officer, estimator or other individual knowledgeable with preparing the bid, is **MANDATORY** and will be considered a pre-condition for bidder eligibility.

Prospective bidders must remain in attendance for the duration of the conference. Prospective bidders who fail to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
